## HOW YOU LEARN

Self-Paced Leaning Activities: Prepare for live sessions using pre-recorded videos, readings, and case studies – delivered at a flexible pace through our Canvas learning management system. Discuss ideas with your peers via a private forum and complete guided self-reflections to help apply key takeaways in your own role.

Live Virtual Faculty-Led Sessions: Join live sessions featuring expert Ivey faculty using any computer, tablet, or mobile device. With the help of a live virtual IT assistant and co-pilot, we use polling, chat, and video conferencing to call on the group in real-time. Virtual learning technology allows faculty to assign instant breakout groups during a larger session. Share experiences, exchange ideas and collaborate to solve challenges with your fellow participants.

Self-Assessments: Individual assessment tools enable deeper self-awareness, encouraging participants to reflect on their learning journey throughout the program. Apply valuable new personal discoveries to your constantly evolving identity as a leader.

Simulations: Simulations teach the application of concepts in critical decision-making moments, requiring participants to apply leadership skills and navigate team dynamics – just like in real life. ## EXPLANATION FOR CASE METHOD

Case method learning is based in experiential learning, inserting the participant into real scenarios faced by professionals in the field; participants navigate the situations themselves, share perspectives with peers and walk away with transferable insights they can take into their own organizations.

## CASE STUDY EXAMPLE

Step into the role of Senior Vice President for the Research and Planning group of Metrobank and tackle the question: how do you plan goal-setting and performance improvement?

Through analyzing the numbers and interviewing key stakeholders in the company to gain insights, you will determine what pain points are causing high employee turnover, poor cost control and inconsistent production standards and plan how to pivot the organization's strategy.

In this case learning experience, we bring the learning to life with live actor role-play sessions, peer discussions and faculty debriefing. Learn to build commitment through participation, communicate clear shared goals across an organization, and help direct reports understand their contributions to a larger strategy.

## 1. How much preparation do I need to do before the course starts?

Preparation time depends on the program itself. In order to maximize the value of your time in class, often self-assessments, case notes, self-reflection activities will need to be completed ahead of the virtual sessions. You should be ready to do 1-2 hours of preparation as required for the program/session.

## 2. What is the time commitment?

The different program offerings range in time commitment, so depending on your course(s) of choice, you should prepare for 20-30 class hours spread between 3-8 weeks.

## 3. To complete a course do I need to do a final exam?

Courses are designed with practical application in mind. Instead of tests or exams, learning is planned around hands-on experiences like simulations and actor role-play. With frameworks and sustainment tools from Ivey, your outcomes are then measured in terms of real-world impact and change – in your role and for your organization.

# 4. If I can't attend the course on the date it is scheduled to begin, will there be future course offered?

## 5. How do I register for the courses?

You can register for the course through our PD portal. After you have registered through the CPA Ontario PD Portal and prior to the start of the course you will receive an email from the Ivey Academy at Ivey Business School welcoming you to the program and providing you with information on how to log in and access your program materials. You must follow the instructions in this email to access and participate in the program.

#### 6. Are there payment options?

There are no payment options available currently. Full payment is required at time of registration.

## 7. If I am not a CPA can I still take the courses?

Yes. The course is designed for specifically for CPAs but is relevant for other financial professionals who want to enhance their leadership capabilities.

Is there homework that needs to be completed outside of the live sessions?
 Yes. Each course includes both in-class sessions, as well as pre-work to complete in advance.

#### 9. If I am away for a live session will it be recorded?

Yes. All the live virtual sessions will be recorded. However, this is a highly interactive course and missing the live virtual sessions may result in not getting the most out of the course. If you need to miss a live session, speak with your instructor about how to keep up with the course.

10. Is there any prerequisite knowledge I need to successfully complete these courses? Beyond the common understanding of business principles and familiarity with how organizations function, no specific knowledge or technical skill is required to benefit from the course. In general, the key to success to all individual courses is a combination of genuine curiosity for learning, preparation of the course materials (reading the cases, etc.), and thoughtful engagement in learning activities.

#### 11. What happens if I can't attend the course after I register for it?

You may cancel your registration and receive a full refund up to seven (7) days in advance of the start of the program. Cancellations within seven (7) days of the program start date, or after the program has started, will incur a withdrawal service charge.
